Request From Sheriff's Department for Part-Time Resource Officer

Mr. Mike Meyer, Finance Director, came before council to present the Sheriff's request. He stated that the position would be part-time with 32 hours per week. The officer will be placed at Estill High School. He stated that the position will be fully funded by the school. **Moved** by Council Member Phillips, seconded by Council Member Parker, to approve the part-time Resource Officers position not to exceed 32 (thirty-two) hours per week via a contractual agreement. Motion carried unanimously.

Retiree Benefits Report

Mr. Mike Meyer, Finance Director, came before council and presented them with a study on the retirees' benefits. He stated that the Governmental Accounting Standards Board (GASB) required that an actuarial study of retiree benefits be completed to determine the county's liability for retiree health care benefits in the future years. He stated that Hampton County contracted with Gabriel Roeder Smith and Company (GRS) to conduct the study. Mr. Meyer stated that the Finance Staff provided employment and benefits data to GRS that was used as the basis of the study. He stated that the study has been completed in accordance with the requirement. Mr. Meyer stated that this is presented to council to study, because it will be an item discussed in budget workshop.
