**DR. A. G. BURRIS, CITIZEN**

Dr. Burris came before council and stated that he served as a member of the South Carolina Forestry Commission but was there as a citizen. He informed council in regards to Hampton County's ranking number 1 in the production and delivery of timber. He informed council that there were great incentives for timber companies. Dr. Burris' questioned council in regards to the schools ranking in the state, the tax base for businesses to locate here and what is the legal government environment of the county. Dr. Burris urged council that they needed to try to get people to move here. Dr. Burris also informed council that there is a lot of surplus that the county may be eligible such as trucks that are no longer in service, surplus from the forestry, but the county doesn't get, because the county never request. Council thanked Dr. Burris for his comments.

**PRESENTATION BY CHAIRMAN HOLLINGSWORTH TO OUTGOING CHAIR  
SHEDRON WILLIAMS:**

Chairman Hollingsworth informed everyone that there have been many who have served as Hampton County Council members since 1878, the beginning of Hampton County; only a small percentage served as chair and out of that percentage we are here to recognize our outgoing chair who in this month is so fitting to recognize as the first African American to service as Chair of the Hampton County Council. Chairman Hollingsworth on behalf of council presented former Chair Shedron Williams a plaque recognizing and honoring his service as chair and in recognition of serving as the first African American Chair of Hampton County Council.

**MR. QUINCY JONES, COMPANY TWO**

Mr. Quincy Jones, Company Two, and stated that he did not request to be put on the agenda. He made a request to the airport commission as an explanation for decision and what can be done by the county. Mr. Jones informed council that on August 25, 2005 he entered into an agreement along with the Hampton County Economic Development Commission with the main reason to do more business here. He informed council that there was a land swap in which he was given a private taxiway to the runway for use without incident. Mr. Jones explained that only three people in the country do what he does. Mr. Jones informed council that he provided the information in the report provided to them. He also stated that if he did not have access to the runway that he would possibly have to move his company. Mr. Jones provided several reasons as to why his company is beneficial to Hampton County and cited several entities who supported his request. Chairman Hollingsworth thanked Mr. Jones.
