ORDINANCE 2019-005

AN ORDINANCE TO MAKE APPROPRIATIONS FOR ORDINARY COUNTY PURPOSES FOR HAMPTON COUNTY FOR THE FISCAL YEAR BEGINNING JULY 1, 2019 AND ENDING JUNE 30, 2020; TO PROVIDE FOR THE EXPENDITURE THEREOF; AND TO PROVIDE FOR REVENUES FOR THE PAYMENT THEREOF.

Section: 1 The following sums of money are hereby appropriated for the purposes herein set forth for Hampton County Government, School District One and School District Two for the period beginning July 1, 2019 and ending June 30, 2020.

The Auditor is hereby authorized to levy, and the Treasurer is empowered to collect 196.8 mills for the General Fund.

There is hereby levied a tax of 20 mills for those areas within the Hampton County Rural Fire Protection District.

There is hereby levied a tax of 1 mill for Fire Capital Reserve.

There is hereby levied a tax of 198 mills for School District one.

There is hereby levied a tax of 299 mills for School District Two.

Section: 2 The Hampton County Treasurer shall not pay any funds in excess of those herein appropriated and collected from any items without express approval by County Council.

Section: 3 The County Administrator shall administer the budget and may authorize the transfer of appropriate funds within departments as necessary to achieve the goals of the budget.

Section: 4 Hampton County shall follow the State of SC Retiree Insurance Benefit Provisions. This Ordinance replaces all other Ordinances/Adopted Policy as it relates to the Retiree Insurance.

Section: 5 Hampton County hereby adopts Attachment A as the approved Legal Holidays to be observed by Hampton County for the Fiscal Year 2019/2020.

Section: 6 The Travel Line item for County Council shall be allocated as follows: Chairman- \$3,500
Vice Chairman, 3 Council Members and Clerk to Council \$2,500 each.

Section: 7 Should any article, section, or provision of this ordinance be, for any reason, held void or invalid, it shall not affect the validity of any other article, section, or provision hereof which is not itself void or invalid.

Section 8. The County Administrator shall hereby be authorized to issue Tax Anticipation Notes as necessary due to shortfall or delay in Revenue Funds.


