ORDINANCE #2021-011

AMENDED ORDINANCE 2021-005, AN ORDINANCE TO MAKE APPROPRIATIONS FOR ORDINARY COUNTY PURPOSES FOR HAMPTON COUNTY FOR THE FISCAL YEAR BEGINNING JULY 1, 2021 AND ENDING JUNE 30, 2022: TO PROVIDE FOR THE EXPENDITURE THEREOF; AND TO PROVIDE FOR REVENUES FOR THE PAYMENT THEREOF.

Section: 1 The following sums of money are hereby appropriated for the purposes herein set forth For Hampton County Government, Hampton County School District for the Period beginning July 1, 2021 and ending June 30, 2022.

Section: 2 The Auditor is hereby authorized to levy; and the Treasurer is empowered to collect the General Fund County Operations 208.09 mills

Section: 3 There is hereby levied a tax of 20 mills for those areas within the Hampton County Rural Fire Protection District.

Section: 4 There is hereby levied a tax of 1 mil for Fire Capital Reserve.

Section: 5 There is hereby levied a tax of 221 mills for the Hampton County School District Operations.

Section: 7 There is hereby levied a tax of 10.2 mills for the approved Financial Recovery/Capital Plan categorized as Committed in the General Fund - Fund Balance

Section: 8 The Hampton County Treasurer shall not pay any funds in excess of those herein appropriated and collected from any items without express approval by County Council.

Section: 9 The County Administrator shall administer the budget and may authorize the transfer of

appropriate funds within departments as necessary to achieve the goals of the budget.


Section: 10 Should any article, section, or provision of this ordinance be, for any reason, held void or invalid, it shall not affect the validity of any other article, section or provision hereof which is not itself void or invalid.

Section: 11 The Administrator shall hereby be authorized to issue Tax Anticipation Notes as necessary due to shortfall or delay in Revenue Funds. The Administrator and or the Finance/HR Director shall notify the Council of the need to secure financing. The Administrator and or the Finance/HR Director shall contact the banking or lending institutions to obtain the best possible interest rate and terms for the County.


This Ordinance No 2021-011 shall be effective July 1, 2021.




