ORDINANCE #2023-007

AN ORDINANCE TO MAKE APPROPRIATIONS FOR ORDINARY COUNTY PURPOSES FOR HAMPTON COUNTY FOR THE FISCAL YEAR BEGINNING JULY 1, 2023, AND ENDING JUNE 30, 2024: TO PROVIDE FOR THE EXPENDITURE THEREOF; AND TO PROVIDE FOR REVENUES FOR THE PAYMENT THEREOF.

Section: 1 The following sums of money are hereby appropriated for the purposes herein set forth for Hampton County Government, Hampton County School District for the period beginning July 1, 2023, and ending June 30, 2024.

Section: 2 The Auditor is hereby authorized to levy; and the Treasurer is empowered to collect 217.5 mills for the General Fund.

Section: 3 There is hereby levied a tax of 20.9 mills for those areas within the Hampton County Rural Fire Protection District.

Section: 4 There is hereby levied a tax of 1.05 mil for Fire Capital Reserve.

Section: 5 There is hereby levied a tax of 233.7 mils for the School District.

Section: 6 There is hereby levied a tax of 10.2 mils for the Financial Recovery/Capital Plan categorized as Committed in the General Fund - Fund Balance

Section: 7 The Hampton County Treasurer shall not pay any funds in excess of those herein appropriated and collected from any items without express approval by County Council.

Section: 8 The County Administrator shall administer the budget and may authorize the transfer of appropriate funds within departments as necessary to achieve the goals of the budget.

Section: 9 Should any article, section, or provision of this ordinance be, for any reason, held void or invalid, it shall not affect the validity of any other article, section, or provision hereof which is not itself void or invalid.

Section: 10 As permitted by Article X, Section 14, of the Constitution of the State of South Carolina, 1895, as amended and Section 11-27-40, Code of Laws of South Carolina, 1976, as amended, County Council is hereby empowered to authorize the issuance of tax anticipation notes (the "TANS") in anticipation of the collection of taxes imposed and levied by this Ordinance. The TANS may be issued at any time or from time to time during the fiscal year beginning July 1, 2023 and ending June 30, 2024; shall be issued pursuant to a Resolution adopted by County Council; may be issued in bearer form or fully registered upon terms and conditions prescribed in such Resolution; shall be issued in the principal amounts, mature and bear interest as prescribed in such Resolution; and may be sold by negotiated or public sale upon such terms and conditions as County Council prescribes in the Resolution.

This Ordinance No 2023-007 shall be effective July 1, 2023.
